Board of Directors - Regular Meeting - July 14th, 2020 - 4:00pm

- 1. Call to Order The meeting was called to order at 4:07pm by Melissa Merida, President.
- 2. Roll Call present via Zoom virtually
 - a. **Present:** Melissa Merida, Sridhar Ramachandran, Jared Law-Penrose, Courtney Lewis, David Clifton
 - b. **Absent:** Susan Rothbauer, Kyle Daugherty
- 3. **Approval of Minutes from Regular and Executive Meeting June 9, 2020.** Motion to approve by Law-Penrose and seconded by Ramachandran. All in favor.
- 4. Approved Public Participation none.

5. Special Reports

- a. <u>Enrollment/Lottery/Marketing Update</u> Glenn reported that the virtual chat has been a huge success and many prospective families have been attending. He stated that enrollment still looks strong for the year, even with a handful of withdrawals this summer. The Early Education program is full.
- b. School Reopening Plan Danielle Manzo and Tracy Pickman Yates, members of the staff committee for Reopening introduced themselves and their roles at the school. They explained a bit about the process of the reopening plan with comments from Glenn and Melissa Weissinger. Barbara reported that 29 staff were a part of the committee for the past couple of months. Barbara explained the On-Campus/Off-Campus Hybrid Learning plan, and the Full-Time Off-Campus Learning plan. Danielle and Barbara talked about the differences in the plan from the various levels, and the goal of trying to keep siblings attending On-Campus on the same day. There was discussion and questions from the Board. Barbara returned to this topic later in the meeting to discuss the Nurtury reopening plan. The Board asked questions.
- c. <u>Human Resources Update</u> Barbara reported that we have one open 6-9 position, and that the rest of the staff looks stable. Susan Rothbauer will be moving from the position of Board Member to serve as the Health Services Coordinator for 4 hours a day during this pandemic. This led to some discussion of whether to add a Board member at this time. The Board will consider postponing this for a time due to the pandemic and will revisit at a later date.

Barbara discussed that the CSP is currently removed from the budget as per discussion with the Board. She discussed that the Board could revisit the possibility of the CSP for the fall based on a percentage of salary (allowing an increase if possible, as no increases were given in contracts this year).
