Board of Directors - Regular Meeting - July 13, 2021 - 4:30pm

- 1. Call to Order the meeting was called to order at 5:45pm by Melissa Merida, President.
- 2. Roll Call present via Google Meet virtually
 - a. **Present:** Melissa Merida, Sridhar Ramachandran, David Clifton, Courtney Lewis, Kyle Daugherty, Ann Brown
 - b. **Absent:** none.
- 3. **Approval of Minutes from Regular Meeting May 11th, 2021** Motion by Daugherty second by Ramachandran, all in favor.
- 4. **Approved Public Participation** (Marriette Siler, Ball State Office of Charter Schools observed the board meeting.)

5. Special Reports -

- a. 2021-2022 School Budget (Including 5 Year Budget) Barbara presented the 5 year budget and discussed adjustments. The Board reviewed the budget and asked questions.
- b. <u>December 2020 Balance Sheet and Statement of Activities -</u> The Board reviewed the statements.
- c. <u>March 2021 School and Nurtury Budget Quarterly</u> The Board reviewed the budget to actual reports. Board agreed that the Nurtury will be moved to the General Fund starting July 2021.
- d. <u>Enrollment/Marketing Update -</u> Glenn reported on the school's enrollment. Total enrollment is proceeding well with the number of learners budgeted for the Charter programs next year set at 535 and it is anticipated that CM will meet or be very near that number by the start of the year. He also commented that CM will continue enrolling through January 2022. There are still a few openings in Early Education.
- e. <u>Expansion Update Melissa reported on the Spring Enrollment giving pledges and paver gifts.</u> She gave a summary of the Spring Celebration held virtually this year.
- f. <u>Grants and Funding Update -</u> Barbara and Melissa gave an update on expected funding over the next couple of years. The Board asked questions.
- g. <u>Human Resources Update</u> Barbara reported that there are currently 4 openings for staff members, and she hopes to have one of these filled by the end of the week.
- h. <u>School Success Update -</u> Barbara reported that the Level Intensives for all school programs are taking place this month, and school success plans will be set at those meetings. This will be impacted in some ways by COVID and testing.
